- 200 cigarettes or 100 cigars.
- 1L of alcoholic beverage.

# Venezuela

- 200 cigarettes and 25 cigars.
- 2L of alcoholic drinks.
- 4 small bottles of perfume.

# **Vietnam**

- 400 cigarettes or 100 cigars or 500g of tobacco.
- 1.5L of spirits over 22% volume or 2L of fortified wines or liqueurs under 22% volume or 3L of other alcoholic drinks.
